

**TUCKER COUNTY BOARD OF HEALTH  
ADOPTS RULE 64CSR30  
ENVIRONMENTAL HEALTH PERMIT FEES**

On April 15, 2020, the West Virginia Legislature passed rule 64CSR30. This rule established the Fees for Environmental Health Permits. On September 21, 2022, the Tucker County Board of Health voted to adopt this rule and the permit fees established in it.

Attached is a chart showing the current permit fees and the proposed changes. The new fees would go into effect on January 1, 2023. This would be the first increase in the county's environmental permit fees since 2008.

The Tucker County Board of Health will accept comments on the proposed change until October 28, 2022.
